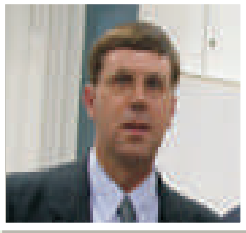

EDITORIAL

AUSTRALIA IS SECULAR



The proposal by Mr Kevin Andrews, Minister for Immigration and Citizenship, to introduce a Citizenship Quiz for applicants for Australian Citizenship demonstrates that he has lost touch with mainstream Australian opinion.

The Minister has failed to demonstrate the need for such a test. Australia has strict immigration laws and all applications to migrate to Australia are closely scrutinized. Applications for Citizenship can be rejected if the applicant has engaged in criminal activity.

The real motive behind this test is wedge politics. We are in an election year and it is to the government's advantage to demonstrate that it is getting tough on Muslims. It is convenient to demonize the Muslim community.

The proposed questions were designed by a group of highly paid public servants who were anxious to please their political master. This group has a poor understanding of Australian history, politics, culture and values. A better job could have been done by the members of a suburban bowls club on a Saturday night.

The questions are contentious, opinionated, value laden and based on a complete lack of understanding of Australian history, culture and values.

The best example is question 15 which states:

"Australia's values are based on the ...

- a. Teachings of the Koran
- b. The Judaeo-Christian tradition
- c. Catholicism
- d. Secularism"

Mr Andrews states that the correct answer is "The Judaeo-Christian Tradition" and regards this as an indisputable historical fact.

The Minister is wrong. Australia is a Secular State. A secular state is a state or country that is officially neutral in matters of religion, neither supporting nor opposing any particular religious beliefs or practices, and has no state religion or equivalent. A secular state also treats all its citizens equally regardless of religion, and does not give preferential treatment for a citizen from a particular religion over other religions.

Australia has a long and proud tradition of Secularism in its public life. The settlers in nineteenth century Australia were predominantly Anglo-Celtic in origin and came from societies that had an established religion. Ireland had an established Church until 1869, Wales until 1920 and there are still established Churches in England and Scotland. At present there are 26 Bishops of the Church of England in the House of Lords.

The Australian Colonies were different to the United Kingdom because no one religion had the support of a majority of the population and there were strong religious divisions between Anglicans, Protestants and Roman Catholics. In order to maintain religious peace, and promote unity, a policy of secularism was introduced.

Secularism has been implemented in different ways in each State. In 1856, the South Australian Parliament took the most extreme step by banning prayers in the opening of Parliamentary sessions. This remained in place until the First World War. The Tasmanian Parliament prohibited the establishment of a Chair of Christian Theology when the University of Tasmania was established in 1890. All States developed public education systems during the 1870s; the slogan that was used was "Free, Compulsory and Secular". Religious instruction was prohibited in all government schools.

The founders of the Commonwealth of Australia were predominantly practicing Christians but they were also committed to the concept of the religiously neutral secular state. The Federal Constitution prohibits the establishment of any one religion by the Commonwealth Parliament and also prohibits any religious test for holding public office.

This tradition of secularism has made Australia an inclusive society where people of all faiths have been able to participate in public life. For example, Australia has had Anglican, Protestant, Roman Catholic and Jewish Governors General.

It is fortunate for Australia that not all Federal Cabinet Ministers reject the secular tradition of Australian society. High profile Roman Catholic Tony Abbot, who is Minister for Health, understands the importance of our secular tradition. ►

In a recent interview on the ABC program Religion Report he stated:

“Ladies and gentlemen, I think it is good to draw a subtle but necessary distinction between faith and public life. I think it's important to maintain a certain separation between faith and public life much as in our political culture, we have drawn a distinction traditionally between church and state. Faith is a very personal thing, either you have it, or you don't. I take faith to mean belief in things which can't be demonstrated in the temporal world, or proven by reason.

Faith should not dictate the politics of any politician in a secular society. Reason should drive the politics of a secular society. Faith, as I said, is intensely personal. My faith is not necessarily the faith of any other person, and yet reason is potentially universalisable in a way that faith can never quite be.”

The credibility of the Citizenship Quiz must be called into question when two members of the Government cannot agree on something as important as the basis of Australian values.

We are in the middle of a long drawn out election campaign. Muslim voters must exercise their political rights and make the question of a Citizenship Quiz an election issue. ■

ABOUT AFIC

History

In 1963 the Muslim community adopted an organisational structure for the cause of Islam in Australia. At the grass root level local Muslims formed Islamic Societies to serve their basic needs in terms of education and prayer facilities. The building Mosques and providing religious education became the primary objective. The Islamic Councils of each State and Territory united to form State Islamic Councils representing their respective Muslim communities at a peak State level. At the national level the State and Territory Islamic Councils formed the Australian Federation of Islamic Councils Inc (AFIC), as the national umbrella organisation for Australian Muslims representing Islam and Muslims at a national and international level. AFIC has its head office in Sydney with branch offices in Melbourne.

As a democratic organisation, AFIC holds Federal Council Meetings with all State and Territory affiliates quarterly and an Annual Congress with all State, Territory Councils and Societies participating. The AFIC Committee of Management is elected every two years by the Annual Congress.

Mission

The mission of AFIC is to provide service to the community in a manner that is in accordance with the teachings of Islam and within the framework of Australian law.

To advocate on behalf of the Muslim community on all such matters that will affect the community's relevance, settlement and integration within Australian society.

Religion and Dawah

As the national Islamic umbrella organisation of Australian Muslims, the AFIC is committed to promote the work of Dawah and other Islamic activities including education and welfare services for Muslims in Australia. AFIC assists with building Mosques projects in remote areas of Australia and assists in the expenses for running these Mosques and Islamic Centres including assistance with salaries of Imams.
